## School Parental Involvement Policy

6. **MCSWSE** shall provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:
- *An informational booth will be held during the September Family Night*
  - *School report cards and State Test results are sent home by student*
7. **MCSWSE** shall take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002):

8. **MCSWSE** shall provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described below –
- *the state's academic content standards,*
  - *the state's student academic achievement standards,*
  - *the state and local academic assessments including alternate assessments,*
  - *the requirements of Title I Part A,*
  - *how to monitor their child's progress, and*
  - *how to work with educators*
- *Schoology allows parents to track students grades daily*
  - *Kickboard allows parents to track students' behavior daily*
  - *Family Night Sessions provide parents information/strategies to help their children with their school work and how to access their grades and content online*
  - *Weekly Newsletters are sent home/posted to Schoology by teachers*
  - *Information regarding State and local assessments are shared with parents*
  - *PD-Training Teachers to Work with Parents*

9. **MCSWSE** shall provide materials and training to help parents work with their children in the areas of improving student achievement, (including literacy training and using technology) child development, child rearing and additional topics parents may request.
- *Sessions to help parents use Schoology and other resources are conducted on Family Nights*
  - *Parent Academy*
10. **MCSWSE** shall, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

  - *Progress Monitoring Meetings are held on a regular basis to track student progress*
  - *SAT Meetings are held in a timely manner*
  - *Family Nights provide parents vital information to help their children*
  - *Professional Development Opportunities*
11. **MCSWSE** shall, to the extent feasible and appropriate, coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, public preschool, and other programs.   - *Parent Academy*
  - *Parent Assistants*
